The Trustee Finance Subcommittee recommended approval of the 2023-2024 Proposed Operating Budget of \$24,521,896 allowing the College to exceed the Revenue Neutral Rate (RNR). Approving the proposed operating budget allows the College to begin fiscal year 2023-2024 on July 1, 2023. The 2023-2024 State Appropriation Budget will be on the August 2023 Board of Trustees Agenda. By the August 2023 Board meeting, the College will have all of the County's estimated assessed valuation information to shore up the Operating and State Appropriation Budget. The administration will adjust the Operation's budget accordingly.
