AQIP	Academic Quality Improvement Program – The college is a quality-driven institution that is committed to a systematic approach to continuous quality improvement.
AS	Associate of Science Degree – degree is intended to prepare students dually for the workforce and for transfer to some baccalaureate programs
AY	Academic Year – the annual period during which a student attends school, college or university. For KHEDS collection AY = Summer + Fall + Spring
Ability to Benefit	Students who do not meet the ability to benefit guidelines will be admitted on a provisional basis, pending satisfactory progress in the essential skills curriculum. These students must earn a semester GPA of 2.0 to be eligible for continued enrollment or be placed on academic probation.
Academic Affairs Council	The Academic Affairs Council has been established to provide advice and assistance to the President and Chief Academic Officer in the development of policies and procedures relating to faculty affairs. the Kansas Board of Regents and makes recommendation to the Regents regarding the coordination, statewide planning
and improvements/enhancements to the postsecondary technical education system.
A student who is between the ages of 18 and 22 years old taking credit bearing courses and has received a high school
diploma.
The official form which documents the college courses the student has completed.
A form used by only one office to manage internal procedures.
A pre-college program dedicated to helping high school students prepare for college or vocational-technical schools.
Students may have a grade of W posted on their transcript instead of a letter grade by officially withdrawing from a
course. To officially withdraw, students need to obtain their instructor's signature on a withdrawal form which then is
processed in the Admissions and Records office.
Every student completing an Associate of Applied Science degree from Cowley College is required to take the WorkKeys
assessment in the areas of Applied Math and Reading.
A failing grade due to a violation of the academic integrity policy.
